

Invitation for bids

- 1. Eligible bidders shall be classified by the GTD as Grade (4) or Grade (5) in the field of construction or Construction Maintenance or Grade (2) or (3) Metal structures. The Bidder shall provide the latest certificate from the Jordanian Construction Contractors Association, a valid professional practice certificate, commerce chamber registration, the company register, and the power of attorney.
- 2. The material in this tender should comply with Geographical code 937.
- 3. Bidders shall comply with US Government code #937.
