# Implement Water Network Restructuring Works At Five Localities Nahleh Ketteh Raimoon Sakib And Hasainyyat -Mi'arad District

1. Yarmouk Water Company (hereinafter called "The Employer") invites eligible bidders to tender for the project of "Implement Water Network Restructuring Works At Five Localities Nahleh Ketteh Raimoon Sakib And Hasainyyat -Mi'arad District.

2. The scope of work comprises the supply, install, test, integrate and commission of all required materials for Restructuring and Upgrading of Al Mi'arad District Water networks , the district formed from five localities . The Contractor shall be fully responsible for providing all necessary materials for completion of the work. The project component is to create restructured system of distribution zones and DMAs, the objectives of the DMAs is to control supply, pressure management and facilitate identifying leakage locations to provide preventive procedures to reduce NRW.

The contractor will be responsible for the following:

- Restructuring and isolation, of Al Mi'arad district distribution network system including the five localities.
- Supply, install and commission of water pipelines including all fittings, valves with all types, flow meters for DMAs, and accessories.
- Construct new chambers for all valves and district meters as illustrated in the BOQ and Drawings.
- The contactor shall provide the employer with training for one month before handing over the works to the Employer
- The training will be for operating the networks, valves, PRVs and water meters.
- The contractor shall conduct NRW measurements pre-post any NRW reduction works using Flow Balance (FB) Approach as explained in the scope of work.
- 3. The nationality of the contractor and/or Subcontractors shall be according to USAID geographical code #937 (The United States, the recipient country, and developing countries other than advanced developing countries).
- 4. The material in this tender should comply with Geographic Code 937 and Ductile Iron pipes comply with Code 935. (The bidders can download the code details from (USAID Web site)

- 5. The bidder must satisfy a valid classification as First or Second Grade in the field of Water/Wastewater from the Ministry of Public Works and Housing and Jordanian Association of Contractors as per the Ministry of Public Works and Housing Government Tenders Department (GTD) classification system. For JV conditions.
- 6. The bidder should provide proven evidence of his financial viability to execute such a project. Audited financial statements of the last years (2019, 2020, 2021, 2022, and 2023) shall be provided by the bidder as a minimum. The average construction turnover for these five years shall be at least 1.5 million Jordanian dinars.
- 7. The proposals submitted by the bidders shall comprise Three sealed envelopes marked as envelope No. 1, "Tender Security," envelope No.2, "Technical Proposal," and envelope No.3 "Financial Proposal," as the following:
  - a) **Envelope** (1) Tender Guarantee (Bid Security), with the value of **75,000JD**, valid for **180 days** after the deadline for bid submission, issued by a Jordanian bank or by a foreign bank through a correspondent bank located in Jordan and shall be acceptable to the Employer or a certified cheque.
  - b) **Envelope** (2) Technical Proposal as per section.
  - c) **Envelope (3)** Financial Offer, which shall contain the following:
    - The duly filled-in Form of Bid (Letter of Tender) and
    - The Financial Offer (Schedule of Prices) is stamped and signed as required.

All three sealed envelopes shall be contained in sealed Envelope (4).

- **8.** This tender is funded by USAID, and the items listed in this tender are subject to zero sales taxes.
- 9. Tender advertisement costs will be borne by the winning bidder
- 10. The Employer has the right to cancel the Tenders without bearing any financial or legal obligations
- 11. The Employer will not be responsible for lost and/or undelivered documents sent by mail Fax, or similar means.
- 12. The Employer reserves the right to accept or reject any offer, annul the bid, and cancel the procurement process at any time without incurring any liability to Bidders.
- 13. All information provided/submitted by the tenderers shall be accurate, correct, and duly certified.
